- 1. CALL TO ORDER; ROLL CALL
- 2. Public Comment: Citizens are allowed 3 minutes to speak. The Princeton Home Rule Charter Commission ("HRCC") is unable to respond to or discuss any issues that are brought up during this section that are not on the agenda, other than to make statements of specific factual information in response to a citizen's inquiry or to recite existing policy in response to the inquiry.
- 3. Consent Agenda: All consent agenda items listed are considered to be routine by the HRCC and will be enacted by one motion. There will be no separate discussion of these items unless an HRCC voting member so requests, in which event the item will be removed from the Consent Agenda and be considered during the course of the regular agenda.
  - a. Adoption of the draft minutes of the HRCC March 2, 2022 meeting as the official minutes for said meeting.
  - b. Adopting updates to the HRCC roster to reflect exchanges of alternates and voting members.
  - 4. Discussions and deliberations regarding the formation of a charter for the

**City of Princeton, Texas.** Unless otherwise specified by the HRCC's motion to adopt a change to the draft charter, adoption of modified language for one section of the charter shall include adoption of harmonizing modifications to other sections which concern the same subject matter to eliminate conflicts between provisions and ensure that the HRCC's decision is accurately reflected throughout the draft document. A listing of specific sections below does not limit the HRCC to discussion or deliberations regarding other sections of the same chapters. This meeting, as time allows, the HRCC plans to discuss the provisions for:

## a. Chapter One: Incorporation and Boundaries

i. Sec. 1.04 Annexations and Disannexations.

At this meeting, HRCC deliberations shall include consideration of variations on replacement language for these provisions, and may vote on the selection of same.

## b. Chapter Two: Form of Government

i. Sec. 2.01 Form of Government

At this meeting, HRCC deliberations shall include consideration of the number of members on the City Council, the manner of their election (at-large versus districts), and potential resident threshold triggers for self-activating changes those components, and may vote on selections for same.

- c. Chapter Three: City Council
- 5. Discussion and potential action regarding meeting calendar and setting agenda items for the next HRCC meeting, scheduled for April 6, 2022.
